

## Summer Splash Sweepstakes & Instant Win Official Rules

**NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**1. Eligibility:** Summer Splash Sweepstakes & Instant Win (the "Promotion") is open only to legal residents of Alberta, New Brunswick, Newfoundland, Nova Scotia, Ontario, Prince Edward Island, Quebec, Saskatchewan, Alaska, Arizona, California, Florida, Hawaii, and Louisiana who are at least eighteen (18) years old at the time of entry. Employees of Dollar Financial Group, Inc., National Money Mart Company, Merkle Inc., and their parent and affiliate companies, suppliers as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. **3. Timing:** The Promotion begins on July 6, 2022 at 12:00 a.m. United States Eastern Time ("ET") and ends on August 23, 2022 at 11:59 p.m. ET (the "Promotion Period"). Administrator's computer is the official time keeping device for this Promotion.

There are two (2) Sweepstakes grand prize pools (each a "Grand Prize Pool") and two (2) Instant Win Game prize pools (each an "Instant Win Game Prize Pool"). Once you submit the form, visit a participating Money Mart Canada, Money Mart US, Insta Cheques Canada, or The Check Cashing Store location and complete one of the following in-store, online, or app† transactions (each a “Transaction”) where customer information [including but not limited to name, mailing address, email address, or date of birth] is exchanged/ recorded at the point of sale. Eligible Transactions will vary by Province/State. Examples of such transactions include:

1. Installment Loan application, approval & funding
2. Installment Loan Refinance
3. Installment Loan Top-Up
4. Multi-Payment Loan application, approval, and funding
5. Single payment loan application, approval, and funding
6. Cash a check of any kind
7. Momentum or Titanium Prepaid Mastercard transaction

Follow the links and instructions to play the Instant Win Game. The Instant Win Game results will be instantly displayed. Potential winners of the Instant Win Game will be provided directions for validation. All potential winners are subject to verification before any prize will be awarded. Administrator is responsible for the functionality of the Instant Win Game.

**Limit:** Each entrant may play one (1) time per day during the Promotion Period. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of plays by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's plays and that entrant may be disqualified. **6. Sweepstakes/Instant Win Game:** Administrator is an independent judging organization whose decisions as to the administration and operation of the Promotion and the selection of potential winners are final and binding in all matters related to the Promotion. **Sweepstakes:** Administrator will randomly select each potential Grand Prize winner from all eligible entries received for each respective Grand Prize Pool during the Promotion Period on or around September 19, 2022. The drawings will be conducted on Sponsor's behalf by Administrator at approximately 12:00 p.m. ET in Southfield, MI. **Instant Win Game:** One thousand seven hundred twenty-eight (1,728) (eight hundred sixty-four (864) per Instant Win Game Prize Pool) random, computer-generated winning times, one for each prize listed below, will be generated during the Promotion Period. If you are the first player to play the Instant Win Game at or after one of the

randomly generated times, you will be a potential instant winner of the prize indicated.

Each Sweepstakes Grand Prize winner (parent/legal guardian if winner is a minor in his/her place of residence) will be required to sign and return a Declaration of Compliance, Liability and Publicity Release ("Declaration"), which must be received by Administrator within five (5) days of the date notice or attempted notice is sent, in order to claim his/her prize. If a potential winner is a Canadian resident, he/she will be required to complete IRS Form W-8BEN. Approximate Retail Value ("ARV"): \$10,000.00. Odds of winning a Sweepstakes Grand Prize depend on the number of eligible entries received during the Promotion Period for each respective Grand Prize Pool. Limit: One (1) Sweepstakes prize per person.

#### **Instant Win Game Prizes:**

EIGHT HUNDRED SIXTY-FOUR (864) US FIRST PRIZES (Awarded to the US Instant Win Game Prize Pool): A \$20.00 Amazon.com digital gift card. ARV: \$20.00. EIGHT HUNDRED SIXTY-FOUR (864) CANADA FIRST PRIZES (Awarded to the Canada Instant Win Game Prize Pool): A \$20.00 Amazon.com digital gift card. ARV: \$20.00. Odds of winning an Instant Win Game prize depend on the number of Instant Win prizes available divided by the number of eligible Instant Win Game plays. Limit: One (1) Instant Win Game prize per person.

If a Grand Prize winner is a resident of the United States, they will receive an IRS form 1099 and will be responsible for all taxes associated with acceptance of the prize.

For All Prizes: No cash equivalent and all prizes are non-transferable, and no substitution will be made except as provided herein at the Sponsor's sole discretion. Sponsor reserves the right to substitute a prize for one of equal or greater value if the designated prize should become unavailable for any reason. **10. entering this Promotion, but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
